- Eligibility for advanced placement requires a person to be a graduate of a two-year ARRT accredited Radiography program. Applicants may be eligible *pending* graduation and certification as follows:
Applicants **currently enrolled in a two-year ARRT accredited Radiography program may apply after completing their first full year of the program.** An official transcript showing completion of the first year is required.*
- Graduates of an Associate Degree or Bachelors Degree Nursing program may be considered on a case-by-case basis for acceptance. Students must be Nursing Board eligible. Before applying contact a program counselor at (715) 833-6346.

LENGTH OF PROGRAM: Associate Degree – 2 Years

STEPS FOR ADMISSION:

1. Submit [Application for Admission](#)
2. \$30 application processing fee – this must be paid *at time of application*
3. **Education requirement:** Applicant must be a high school graduate, or have completed the High School Equivalency Diploma (HSED) or the General Education Development Certificate (GED)

Note: If you have an international diploma or degree, additional admission requirements may apply.

4. Submit official transcript(s) of your postsecondary education in the Radiography field (*see above remarks)
5. Submit proof of registration/certification in a Radiography field (*see above remarks)
6. Submit a completed Background Information Disclosure Form, the Wisconsin Criminal History Single Name Record Request Form and a \$20.00 background processing fee. These forms are available on the web at <http://www.cvtc.edu/pages/298.asp> or can be supplied to the student by CVTC.

Once all the above items have been completed, you will be considered for enrollment based on current openings in the program. It is to your benefit to apply on-line ([Application for Admission](#)) and complete all required items as soon as possible.

Additional requirements for this program:

- Proof of CPR-Certification by the American Heart Association - *Healthcare Provider Level* or the American Red Cross - *Professional Rescuer Level* must be on file before entering core courses of the program.
- A *Pre-Entrance Health History and Physical Examination* must be on file three weeks prior to entering the core program courses. The Admissions Office will notify you at the appropriate time with a specified deadline.
- Students can expect to be placed in clinical training sites throughout Wisconsin, Minnesota, Iowa, Illinois, and Michigan.

PREGNANCY POLICY

Upon learning of a pregnancy, it is the student's responsibility to notify the program faculty. The student may continue with the program under the following conditions to protect the mother and child.

1. Student must submit a physician's written authorization to the faculty.
2. After delivery the student will be readmitted to the program with a physician's written authorization.
3. Student is required to make up all clinical hours missed until all necessary course competencies are complete.
