Students wanting to be a licensed barber/cosmetologist are mandated by Wisconsin law to attend a minimum of 1,800 hours of instruction. Students enrolled at CVTC take classes spread over a 14-month period of time. In addition, a student must maintain a 2.0 grade point average (GPA) on a 4.0 grade scale. Failure to comply with both hour and grade requirements of a course will result in an incomplete or failure of the course. Courses can be repeated if necessary; student must notify Admissions to get name back on application list.

LENGTH OF PROGRAM: 48 weeks of instruction

STEPS FOR ADMISSION:

1. Submit [Application for Admission](#)
2. **\$30 application processing fee – this must be paid *at time of application***
3. **Education Requirement*: Applicants who did not graduate from high school, are not currently high school seniors, and did not receive an HSED or GED diploma must complete the following:**
A COMPASS pre-entry Ability to Benefit assessment:
 - Achieve scores of at least 25 in math, 62 in reading, and 32 in writing, and
 - Complete a counseling session with a counselor.

***Note:** If you have an international diploma or degree, additional admission requirements may apply.
4. **COMPASS Pre-entry Assessment.** Compass is an un-timed, computerized test of **reading** and **math**. Scores are used for advisement purposes.

 - **Substitutions of the COMPASS** will be made for those that can provide proof of one of the following:
 - ~ **ACT:** Applicants must achieve a minimum composite score of **18** on the ACT. Reading and Math scores are required for class placement and advisement purposes only – no minimum. If the ACT composite score does not meet the minimum, applicants will need to take the COMPASS pre-entry assessment.
 - ~ **Associate Degree, Bachelor's Degree or higher:** A transcript is required showing proof of degree awarded.

Once all the above items have been completed, you will be considered for enrollment based on current openings in the program. It is to your benefit to apply on-line ([Application for Admission](#)) and complete all required items as soon as possible.
